Water quality

Tariff dispute

Local Court Case

- Dispute started in 2011.
- On 12th December 2017, Supreme Court made a final decision on AS Tallinna Vesi's appeal in cassation in the dispute between AS Tallinna Vesi and the Competition Authority. Supreme Court decided to partly uphold AS Tallinna Vesi's appeal in cassation.
- On 4th December 2018 CA did not approve the water and wastewater tariffs in Tallinn and Saue.
- On 14th March 2019 the Company disputed the decision in Tallinn Administrative Court

International Court Case

- International arbitration proceedings (ICSID) commenced in October 2014
- Hearings were held in Paris, in November 2016
- EC were allowed to make a limited submission as a non-disputing party
- Negative decision on 21st June 2019 with the dissent from one of the panel members


