





Tariff application

- First tariff application February 2018, taken into proceedings May 2018
- 4 December 2018 CA did not approve the water and wastewater tariffs in Tallinn and Saue.
- 2 September 2019 New tariff application to CA tariffs ca 20% lower on average
- 18 October 2019 CA approved the tariffs
- 1 December 2019 New tariffs will be effective

Revenues, € million




Volumes, million m³


